Guest Commentary-

Mike and Brooke Dunk: Gold Hill Auto Parts was wanting to see if the City will fix water leaking into the building from Fulton St. being built up over time and the water running south. They also have interest in making a community building out of the east side of their business. It needs remodeling and an HVAC system. They are willing to do a \$15,000 match with the City for a community center/Spirit of Shawneetown storage area. TIF committee will discuss community building and the City will look into Motor Fuel money for the drainage.

Megan Ragan: Sullivan Electrical work is done and up to code. Security system to be put in. Tim Robinson will be the contractor for the renovations. Should all be done in about a month. 3 grant-funded positions have been approved. USDA may help with the food bank and laundry mat.
